What better example than the Lambton Seniors who have been receiving a Venture Grant up until now, to provide the Handy Man/Handy Woman program.

Simple tasks to most of us like changing a light bulb can cause serious injury to a frail senior. Now, the Lambton Seniors' Association can assist with tasks like these that prevent seniors from putting themselves at risk of a serious injury. These simple tasks left undone, or done unsafely, might result in the senior having to leave the family home and go to live in a long term care term facility, or hospital bed.
