

President's Report

Year 2022 provided a number of ups and downs for our United Way.

While we are disappointed that we did not reach our needs target of 1.65 million, there were a number of very positive things that

came out of our most recent campaign.

The 2022 campaign picked up a number of new donors, and a substantial number of donors increased their contributions this year over last year. Our social media analytics also spiked in 2022, all of which pose well for the 2023 campaign. We also had some very successful events and many of the employee campaigns exceeded their 2021 results.

In addition, our partner foundation, the Sarnia-Lambton Future Fund Foundation was spun off in 2022. The foundation will generate additional revenues to have its largest financial impact on the United Way, reducing our costs and enabling additional funds to go to local agencies. This is key to our overall sustainability and keeping our costs low.

During the year, Rebecca Brander, our Resource Development Manager left the United Way to pursue another career opportunity and at the conclusion of this year, we are also saying goodbye to some long time Board Members. I would very much like to thank our retiring board members, Martin Vrolyk, Michele Lalonge-Davey, Richard Kelch, and Kelly Batson for all their commitment and hard work over the years.

During 2022, the Community Investment Committee, under the leadership of Gerry Whitcombe, continued to make some excellent investment decisions in terms of funding over 30 programs and services in our community. These programs and services have a measurable impact on the lives of so many in Sarnia and Lambton County.

I would like to thank all of our donors, volunteers, sponsors, and of course, the local media; without their confidence and support, our community investments simply could not happen.

The staff team at the United Way, once again, pulled together, and were in sync with the great work of our volunteer Board of Directors. We are fortunate to have the staff that we do, many of them have been with us for decades, who I consider key assets to our organization.

The local media have all been very helpful in assisting us in getting our messages out to the public, and we appreciate all of their efforts as well.

I am excited to work with our new board nominees, Shelley Gartshore, who is our 2023 Sarnia and District Labour Council representative, Krista Randall, Jill Joseph, and Sarah Craig.

I am looking forward to 2023, I believe with the continuing support of our community, we will be in a position to support even more programs and services in the future as a result of a successful 2023 campaign. The fundraising has already begun, and we anticipate approving our three-year strategic plan early in the year.
